Contest Terms and Conditions

Dmela19selfie contest (**“the Contest”**) is organized by IndogoTV, owned by Seven Hills Top Sdn Bhd (1038581-M) hereby known as the “Organizer”. This contest consists of one (1) round for a continuous period, from 1st October, Tuesday, 19:00 to 25th October 2019, Friday, 12:00 (GMT+08:00) (**“the Contest Period”**) or any period as notified by the Organizer on IndogoTV Facebook page. The Organizer may, at its sole and absolute discretion extend the Contest Period at any time without any prior notice to any party (the “Extended Period”).

Duration of Contest

19:00, 1st October to 12:00, 25th October 2019

Contest Mechanics

1. To participate in the contest, contestants must have an Instagram account with its privacy settings set to “Public”
2. Contestants must Like and be a fan of the IndogoTV Instagram page.
3. Contestants must take their best selfie (usage of any smartphones are eligible for this contest).
4. Contestants must upload the selfie on Instagram, tag @indogotv, tag the location and #Dmela19selfie #indogotv. The selfie must be taken at Little

India-Tengku Kelana, Klang and its surrounding areas with the Deepavali atmosphere.

5. Contest winner will be announced on IndogoTV Facebook and Instagram. It is the responsibility of contestants to follow this announcement closely.
6. The Organizer reserves the right to reject any contestant at its sole and absolute discretion, without having to assign any reasons whatsoever.

3. The winner will be announced on www.facebook.com/IndoGoTV and www.instagram.com/indogo_tv between **1700 and 1900 on 25th October 2019**, and he/she will need to and agree to send a Private Message to the Organizer on Instagram (Indogotv) with his/her contact details for prize collection.

Those unable to collect may collect them at our office.
